Thanks, Rick. These will be perfect to include for the DDA meeting in March.

I would anticipate a couple of questions that might come up with the design. The DDA was hoping to accomplish a couple of irrigated raised planters, maybe in lieu of a street tree or two. I had always understood those would be covered under the line item for "seat walls." The drawing makes those look more like areas of built-in benches. Can you confirm whether the budget/design are going to support some new landscape areas along the streetscape?

Also, it looks like the outside lane treatment in front of the Middle School has changed from dedicated bike lanes to sharrows/tapered driving lanes. I am thinking you alluded to this in the call as maybe have been driven by an MDOT review? Now that I see it, I think we will need some discussion/clarification with the DDA. I'd anticipate some concerns with keeping a passing lane over that short distance, especially in front of the Middle School with morning/afternoon student drop off and pick up.

Let me know if there is anything that we should cover here prior to the March meeting.

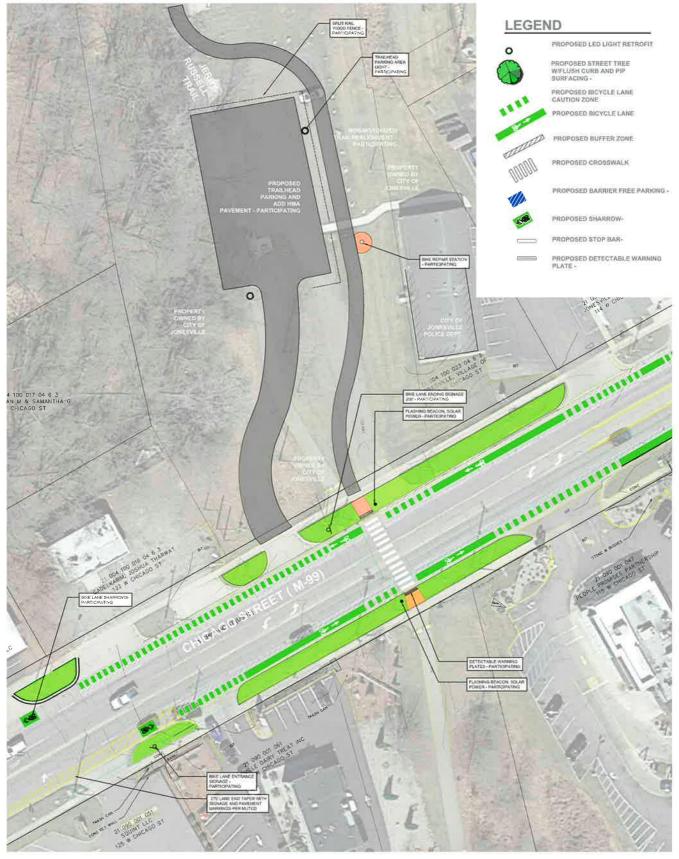

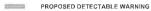

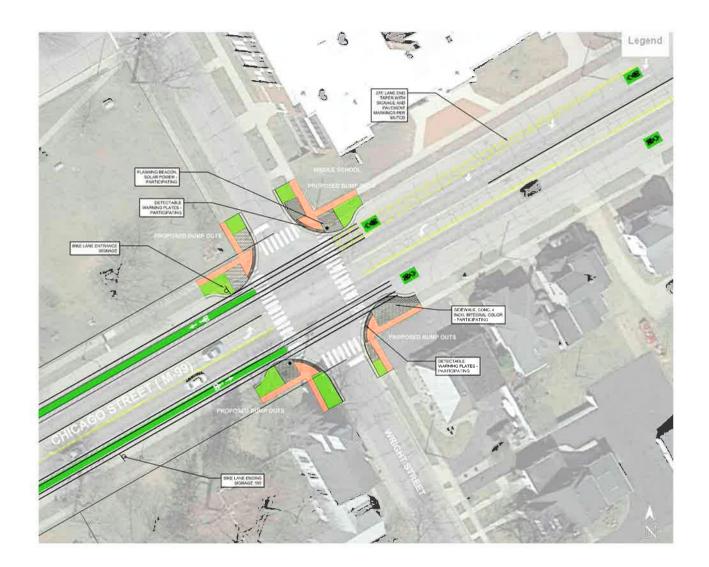

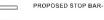
