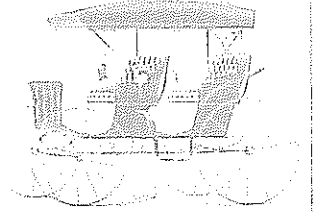

Vendor Rules And Regulations

1. All vendors must be registered with the Village of Jonesville.
2. Individual vendors are responsible for obtaining all licenses and/or permits required by the Public Health Department and the State of Michigan.
3. Individual vendors are also responsible for any requirements to collect and remit Michigan Sales Tax
4. Seasonal market hours will be from 2 p.m. to 6 p.m. Wednesday, Thursday, and Fridays on the North side of G. Carl Fast Park along the South side of Park Street. Selling area may be set up 1/2 hour before market opens. Tables only, no tents are allowed.
5. Any and all vendor generated waste, rubbish or trash must leave the market with the vendor.
6. Items permitted for sale at the Market are limited to produce, flowers, fruits, herbs, and plants. No commercial or flea-market type items will be permitted. The Village must approve items in question prior to sale. Dairy products, including cheese, milk or butter, are specifically prohibited.
7. All Produce must be fresh, high quality, in season and Michigan grown.
8. Vendor spaces have approximate dimensions of 10' x 20'. Multiple spaces may be permitted on the basis of availability. No selling is permitted outside assigned spaces. Vendors are responsible for cleanliness of their individual spaces both during and at the end of the sales time.
9. All foods shall be clean, wholesome, and safe for human consumption. Vendors shall not be permitted to display or sell spoiled or decayed product. No food may be offered by way of sample, except on a one-to-one basis. No foods may be prepared for consumption in the Farmer Market area.
10. The Village of Jonesville shall not be liable or responsible for transactions made between buyer and seller. In addition, the Village of Jonesville shall not be responsible for theft, lost or stolen articles, or accidents.
11. Rules are subject to change at the discretion of the Village of Jonesville. The Village of Jonesville reserves the right to expel or refuse admittance to those who upset the quiet enjoyment of the Farmer's Market activity or violate any of the above rules.
